Public notice is hereby given that the bi-monthly meeting of the Board of Trustees of the Village of Leawood, MO will be held at 6:30 P.M. on **Wednesday, November 16, 2011** to consider and act upon the matters on the following agenda and other subject matters as may be presented at the meeting and determined to be appropriate for discussion at that time. **The meeting will be conducted at the Redings Mill Fire Station, 344 Redings Mill Road.** Please note this is a change from the normal meeting location on Rangeline.

Financial Information- October 31, 2011

2011 (ten months) revenues of \$69,545 (includes \$13,464 real estate taxes) were significantly lower than expenses of \$119,767 for a net deficit of \$50,221 due the \$103,180 expenditure for road repairs. As a result the cash balance decreased from \$119,540 to \$69,319. As of October 31st the balance in the General Fund are \$60,690 and the DOR Road Fund is \$5,629 and the Boyd Restitution Fund is \$3,000.

The cash balances at Community Bank and Trust are \$33,997 in checking and \$35,322 in money market for a total of \$69,319 which are \$1,200 lower than the CBT statements due to an outstanding check.

YTD revenues exceeded budget by \$8,305 and prior year by \$4,660. Expenses are \$79,149 above budget, due to spending \$83,180 above the \$20,000 budget for road repair, and are \$96,462 above prior year due the total \$103,180 expenditure for road repair compared to zero last year.

There will be a public hearing at the Calvary Baptist Church located at 600 East 50th Street, Joplin MO at 6:30 P.M. on December 1, 2011 before the Planning and Zoning Commission of the Village of Leawood and on December 8, 2011 before the Board of Trustees of the Village of Leawood to consider the request of David A. Southern Hills Barrier Removal

Wattelet (resident Southern Hills) Mitch Randles (Joplin Fire Chief) and Jack Stults (as a member of the Wildwood Homeowners Association) have requested that the barrier on Valleyview Drive be removed. This barrier was put in place in 2006 to Southern Hills separate and adiacent Wildwood due to excessive Wildwood traffic which resulted in safety issues for residents of Southern Hills and deterioration of roads in Southern Hills. St John's Hospital

Brad Long and Denny Desmond represented the Board of Trustees at the October 10th the Joplin zoning hearing for St. John's. Desmond read his prepared remarks in opposition of the zoning from residential to commercial. The zoning request was unanimously approved. Long and Desmond were invited to a meeting on October 17th with representatives of St. John's and the City of Joplin to voice our road concerns and review the tentative plans for roads. St. John's seems committed to listen to input and be a "good neighbor."
