Notice of Open Public Meeting

Public notice is hereby given that The Board of Trustees will have their bi-monthly meeting at 6:30 P.M. Tuesday, January 21, 2014 and to consider and act upon the matters on the following agenda and other subject matters as may be presented at the meeting and determined to be appropriate for discussion at time Planning and Zoning Commission will meet at 6:00 prior to the trustee meeting. The agenda will include (1) Update status of Comprehensive Plan by HSTCC, (2) Update status of road improvements in 2014, and (3) Review building request permit from Communications.

- Update the status of the Comprehensive Plan

Financial Information- December 31, 2013

2013 (twelve months) revenues of \$68,732 (includes \$16,765 real estate taxes) were significantly higher than expenses of \$30,037 for a net surplus of \$38,695. As a result the cash balance increased from \$118,241 to \$156,936. As of December 31 the balance in the General Fund is \$134,786 and the DOR Road Fund is \$22,150. The cash balances at Community Bank and Trust are \$75,367 in checking and \$85,569 in money market, which totals \$160,936 (check #2275 to Big John's Heavy Equipment for \$4,000 is outstanding).

2013 revenues are above budget by \$1,842 (+\$765 real estate taxes and +\$765 franchise taxes from Empire)) and prior year by \$1,642 (+\$978 real estate taxes and +\$1,006 franchise taxes). Expenses are above budget by \$4,112 due to engineering costs of \$5,000 for the 2014 road plan and \$4,000 for a ditch repair on Brookwood Drive, which was partially offset by \$2,913 lower legal fees. Expenses are \$2,679 higher than last year due to road repairs (+5,700) and liability insurance (+\$2,742), which were partially offset by lower legal fees (-\$3,550) and street signs (-\$1,104)

Comprehensive Plan (CP)

A public meeting was held on October 22nd to kick-off the process for а new Comprehensive Plan (CP). 89 surveys have been submitted to HSTCC, who is coordinating the process for the CP. The CP Committee met twice to review the results. The CP status will be reviewed by HSTCC at the January 21st P & Z meeting. The CP process will (1) identify and objectives. goals complete a S.W.O.T. analysis (strengths, weaknesses, opportunities and threats) and (3) a future land use map for Leawood. Once these are reviewed at a special public meeting in February, then implementation strategies will be established. The target for approval of the CP is at our March meeting.

April 8, 2014 Election

Any qualified resident interested in filing for the April 8 2014 election to the Board of Trustees must file by January 21, 2014 and, must contact Denny Desmond at 781-3558. Two incumbents, Fran Owen and Caleb Head have committed to file. The term is for two years.
