Financial Information - December 31, 2022

In August, the second installment of \$68,659 from the American Rescue Plan Act was received. The balance ARPA fund is \$137,518. \$45,000 expenditures were lower than \$186,094 revenues for +\$141,094 surplus (without \$68,659 from ARPA, normal surplus \$71,679) which increased cash to \$452,892. Normal revenues of \$116,679 exceed budget by \$32,513 due to +11,894 sales taxes, +\$8,880 Missouri DOR, +8,315 franchise taxes and +\$3,591 real estate taxes. Revenues exceeded last year by \$13,034 due to +\$7,062 sales taxes, +\$2,936 Missouri DOR and +\$3,364 franchise taxes.

Expenditures of \$45,000 are \$84,514 below budget due to \$27,749 lower expenses for consulting for issues related to 44th street Joplin construction/water issues, -\$42,000 due to delaying the tree trimming to 2023, -\$7,880 legal fees, -\$1,800 snow plowing and -\$2,763 minor road repairs. Expenditures were lower than last year due to -\$11,273 street signs, which was slightly offset by the replacement of cement barrier with gate cost of \$3,776. Balances in bank accounts are \$452,892 with \$119,589 (checking/operating), \$97,779 (money market/savings) and \$98,007 (sales tax account) and the American Rescue Plan Act (ARPA) fund \$137,518.

Message from your Chairman

I have been a member of the Board of Trustees since 2000 (22 years) and Chairman for 20 years. My grandkids have asked me "how do you get a position like that (they call me Mayor of Leawood). My response won't be a surprise: "No one else has volunteered." Other trustees have been on the board for many years. The trustees average age if 70++. With that said I will run for reelection in 2023 but not 2025, when I will be seventy-eight.

City of Joplin – 44th and Connecticut

Due to concerns about the existing and potential water run-off from this completed project and other potential developments, earlier this year a hydro engineer from Columbia MO was retained to conduct a site review and review the City of Joplin's details for the project. After a few meetings and further analysis/review by their engineers/consultants, Joplin advised "the City recognizes and relies on its experts that have concluded that the City has lessened the impact of the storm water runoff in that area. The City considers the matter fully resolved."
