Financial Information - August 31, 2023

Expenditures of \$30,913 are \$34,786 below budget as the cost for trimming was \$8,900 versus the \$42,000 budget. The cost for dumpsters was \$5,241 compared to \$3,044 last May. \$81,706 revenues exceeded budget by \$734. The \$50,792 surplus increased cash to \$503,682 Since our Money Market was earning .25% annual interest, \$400,000 Certificates of Deposits with 3.51% interest rate and eleven-month maturity were purchased on March 29th These will provide an additional \$12,870 interest. Separate CDs were purchased. These will provide an additional \$12,870 interest. Separate CDs were purchased with funds from APRA (\$137,517.76) sales tax (\$95,000) and operating fund (\$167,482.24). Balances in bank accounts are \$103,682 with \$30,498 checking/operating, \$55,457 money market/savings and \$17,727 sales tax account.

Work Session for Funding Request

At the July 20th trustee meeting, Rich Reed from the Hidden Valley (HV) Homeowners' Association requested cash funding from Leawood to assist HV to replace their concrete roads. Leawood is not responsible for maintaining HV concrete roads. Since HV pays real estate taxes and helps generate other revenue like franchise taxes and fuel, and vehicle tax/fees it was agreed at the meeting that Leawood should fund some money. The question is how much? Hence the work session to discuss before a proposal is submitted at the November meeting.

School is Back in Session

Please watch out for our children as they wait for school buses in the morning and afternoons. Also remember that it is a state law to stop for schools buses loading and unloading.

.American Rescue Plan Act

Leawood received \$137,517. Previously the funds were restricted by the Act to specific areas including "support vital waste water and storm water infrastructure." In recent update the Treasury has provided more flexibility for spending the money to include the broad category of "government services" Leawood has until December 31, 2004 to spend the money.

2014 Comprehensive Plan

Our first ever Comprehensive Plan was approved in 2014 and must be updated every 10 years. We assisted HSTCC (Harry S Truman Coordinating Council) in 2014 and HSTCC has again agreed to prepare with our assistance the 2024 Plan at the same \$3,000 cost. The 2014 Leawood Comprehensive Plan Committee (13 members) met five times and two special public meetings were held. This same process will again be used.
