# Financial Information - April 30, 2024

\$61,371 revenues exceeded \$28,796 expenses for a \$32,575 surplus. Revenues included \$16,162 real estate taxes \$12,926 interest from CD's, \$11,685 franchise taxes from Liberty, \$10,090 from Missouri DOR for roads and \$9,190 sales taxes. Expenses included \$17,412 ARPA expenditures for storm water project at 47th/Wendi, \$2,500 fee from HSTCC for 2024 comprehensive Plan and \$2,377 for public liability insurance. The \$32,575 surplus increased cash to \$556,637. It includes \$68,223 in checking, \$55,551 in money market, \$19,337 sales tax and \$412,929 in six-month (mature August 28, 2024) certificates of deposit at 5.11% interest rate

#### **Spring Dumpsters**

The six dumpsters were again filled to capacity. There were a few minor abuses, but we worked through it. A special thanks to homeowners, who allowed use of their property for the dumpsters. \$1,100 was saved using Republic instead of GFI. Remember that Republic Services will pick up at no cost one household item per week on the regularly scheduled Tuesday collection day by notifying Republic (800-431-1507) of any such items.

#### **Facebook and Website**

Our postings to Village of Leawood Facebook have increased in the last few months including information about the dumpsters. ## **Deer Population Meeting**

Some residents have expressed concerns about the deer population in the Village and the damage being done to shrubs, flowers, and plants in their yards. A meeting will be held to hear a Missouri Conservation agent, Jerid Wilkinson, speak about deer management practices and answer questions. Residents are invited to attend the meeting on Thursday, May 16th at 6:30 at the Redings Mill Fire Station, 344 Redings Mill Road.

#### **American Rescue Plan Act**

Leawood received \$137,517. Previously the funds use was restricted by Act to specific areas including "support vital wastewater and storm water infrastructure." In a recent update the Treasury has provided more flexibility for spending the money to include the broad category of "government services>" Leawood has until December 31, 2024 to spend/commit the money. \$25,000 has been committed for the Storm water improvements at 47th and Wendi and around \$40,000 will be spend on roads in Hidden Valley; so the remaining balance is \$82,518. Do you have any suggestions?

#### 2024 Comprehensive Plan

The updating our 2024 comprehensive Plan (CP) is moving forward (must be updated every 10 years. The 2024 planning survey was mailed to residents. A future meeting will then be held for residents to finalize the 2024 Comprehensive Plan. The plan should be completed by June 30<sup>th</sup>.
