#### Financial Information - October 31, 2024

\$123,027 revenues exceeded \$58,762 expenses for a \$64,265 surplus. Revenues included \$23,539 interest from Certificates of Deposits. Expenses included \$36,230 ARPA expenditures for storm water project at 47th/Wendi, (\$18,605) and for the storm debris cleanup, (\$17,034). Other expenses included \$3,268 for dumpsters for spring cleanup, \$2,500 fee from HSTCC for 2024 Comprehensive Plan and \$2,377 for public liability insurance. The \$64,255 surplus increased cash to \$558,327. It includes \$76,328 in checking, \$96,309 in money market, \$32,918 sales tax and \$382,862 in six month (mature February 28, 2025) certificates of deposit at 5.05% interest rate.

#### .American Rescue Plan Act

Leawood received \$137,517. Previously the funds use was restricted by Act to specific areas but in an update the Treasury has provided more flexibility for spending the money to include the broad category of "government services." Leawood has until December 31, 2024 to spend/commit the money. YTD \$24,531 has been spent for the storm water improvements at 47th and Wendi, \$17,034 spent on debris removal. Commitments include \$40,000 for roads in Hidden Valley and \$15,000 for four small projects. Due to the estimated \$75,000 cost the storm water issues at 50th/Indiana won't be done (initial estimate \$20,000). The remaining \$35,675 funds balance will be used to crack sealing and micro surfacing the roads in 2025 since Pavement Management did a poor job in fall 2020. A bid request has been sent out by Allgeier Martin. The estimated cost for all roads is \$150,000, which will be in 2025 budge

#### **Comprehensive Plan**

The updating of our 2024 Comprehensive Plan (CP must be updated every 10 years). Harry S. Truman Coordinating Council agreed to prepare with our assistance the 2024 CP at the same \$3,000 cost as in 2014. individual from HSTCC, who was assisting us, resigned. So, after some initial work in the spring nothing has been done. A new individual has been hired and the CP will be completed by December 31st.
