Financial Information – February 28, 2025

YTD (two months) \$32,328 revenues are lower than \$52,740 expenses for a \$20,412 deficit. Revenues included \$17,144 real estate taxes. Expenses included \$43,359 ARPA expenditures. Other expenses included \$2,699 for liability insurance for public officials. The \$20,412 deficit decreased cash to \$527,939. It includes \$12,620 in checking, \$46,596 in money market, and \$35,861 in sales tax and \$432,862 in certificates of deposit at 4.1% interest rate.

Spring Dumpsters

Residents are encouraged to clean up the debris in their yards. Dumpsters will be provided April 25th to April 28th at the same two locations. Unacceptable items include furniture, mattresses, appliances, electronics, and tires/wheels.

Roads - Plans/Costs

The initial phase of crack sealing the roads was completed in December. The \$39,605 cost was twice the approved bid. After the contractor spend two days sealing it was obvious that there significantly more cracks than last time and double the amount would be necessary. The micro surfacing of roads will cost \$136,862 and will be done next summer. Funds from American Rescue Plan Act were used to pay for the crack sealing.

Comprehensive Plan

The update of our 2024 Comprehensive Plan (CP must be updated every 10 years) will be available at the March trustee meeting and will be posted on our website. Harry S Truman Coordinating Council assisted in the preparation at the same \$3,000 cost as in 2014,

April 8, 2025 Election

The filing date for candidates was December 24th for qualified residents who were interested in running for a two-year term for the board of trustees. Dan Gremaud, Dale Owen and Nick Reynolds have filed for election. Denis Desmond, after 25+ years on the board (most recently as Chairperson) decided against filing.

.American Rescue Plan Act

Leawood received \$137,518 from the ARPA in 2021 and 2022. Leawood had until December 31, 2024 to spend/commit the money. As of January 31st all \$137,518 was spent, as required. Spending included: \$24,531 for the storm water improvements on 47th and Wendi; \$17,034 on debris removal from the May storm/ \$40,000 for a portion of Hidden Valley streets; and \$7.000 for drain cover Horseshoe/50th. Commitments include \$39,555 for crack sealing roads and \$3,754 for street repairs in Brookwood.
